[1] Martis Valley assumes water connection to Northstar CSD.

[2] There are subdivisions with different rates based on mutual benefit agreements between the developer and District.

[3] Wastewater treatment fee is included in the wastewater connection fee.

[4] Water and wastewater connection fees are combined.

[5] Gas and electric fees are not included because fees depend on specific location and the infrastructure currently in place. For electric providers other than the TDPUD, connection fees are due prior to service start, not at building permit.

[6] No initial wastewater treatment fee due. All Serene Lakes property owners have been assessed a fee for upgrades to the DSPUD Sewer Treatment Plant. Assessment can be paid as a one time fee of \$10,000 or about \$450/yr for 40 years.
